The Government of Iraq has received financing from the International Bank for Reconstruction and Development (IBRD) toward the cost of the Basra Electricity Dissemination and Development Project (EDDP), and intends to apply part of the proceeds toward payments under the Contract for Design, supply and installation of 132KV, T.T double CCT transmission line with 132 KV equipment for lines panels. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing.
- 2. The Ministry of Electricity (MOE)/South Electricity Transmission Company now invites sealed Bids from eligible Bidders for Design, Supply & installation of transmission line 132kV double circuit Rumaila Investment P.P. station Shuiba in length of approx. 34km
- 3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" *Fourth Edition, November 2020 ("Procurement Regulations")*, and is open to all eligible Bidders as defined in the Procurement Regulations.

A single-stage, one envelope RFB process will be used.

4. Interested eligible Bidders may obtain further information from *Ministry of Electricity/* South Electricity Transmission Company / Commercial Office / Al Tawaissa Sqr., Attention: Assad Muhair Kareem <setco-esrep@moelc.gov.iq> and inspect the bidding document during office hours 09:00 am to 1:00 pm Basra local time at the address given below. The bidding document in *English* may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of *USD 500*. The written Application shall contain clear name and number of the RFB and contact details of the potential Bidder (including active email address for due communication).

The method of payment will be in cash for local bidders or international bidders with representing office in Iraq. The document will be picked up from the Project Management Team (PMT) Office at the address mentioned below.

For the International Bidders, there is also the option to purchase through money transfer and the Bidding Documents to be sent by e-mail. If required, the Bidding Document will be sent by e-mail upon receipt of money transfer to SETCO bank account with the abovementioned non-refundable fee of **USD 500 (net amount)**. The SETCO bank account is available upon request after sending the company credentials and confirming the official email address. Tender documents will not be submitted to the bidder in case the transferred money did not enter into SETCO's bank account. If the money enters the account afterwards it will be returned to the bidder.

- 6. Bids must be delivered to the address below on or before 11:00 AM Local Time 20/11/2023. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 11:00 AM Local Time 20/11/2023.
